### **SECTION 1: INTRODUCTION**

## 1. About Nevada Clean Energy Fund

The Nevada Clean Energy Fund (NCEF) is a nonprofit organization dedicated to supporting a thriving, affordable, and accessible clean energy economy by providing financial and technical resources to Nevadans. NCEF's programs are designed to accelerate clean energy growth in the state, reduce energy costs, create jobs, and meaningfully address climate change. NCEF was established by Nevada statute in 2017 to serve as the state's nonprofit green bank. More information about NCEF is available at nevadacef.org.

## 2. Program Overview

In 2024, the U.S. Environmental Protection Agency (EPA) awarded a \$156 million Solar for All grant to NCEF to implement programs in Nevada that enable communities to benefit from distributed solar energy. The Nevada Solar for All (NSFA) programs must deliver the equivalent of at least 20% monthly savings to every participating household, with a standard monthly savings amount set based on the average utility bill across the utility's service territory. NCEF selected United Way of Southern Nevada as its partner to help administer the NSFA Community Solar Subscriber Program.

This Community Solar Subscriber Program Guidance should be used by households in Nevada who are interested in subscribing to receive monthly payments from community solar systems (referred to as "Subscribers" throughout this document). See Section 2 for details about eligibility and participation.

## SECTION 2: SINGLE-FAMILY SOLAR DIRECT OWNERSHIP PROGRAM

### 1. Description

Under this program, NCEF provides financial and technical assistance to single family homeowners, including a combination of zero-interest and forgivable loans for the installation of residential rooftop solar photovoltaic (PV) systems. Utility bill savings from the solar system, combined with NCEF's financial assistance, are to deliver at least 20% savings to participating households, compared to the average utility bill.

Eligible beneficiaries include low-income and disadvantaged household who own and occupy a single-family home as their primary residence. These participants must also have sufficient tax liability and fall under the low-income and disadvantaged classification as outlined below.

## 2. Types of Assistance Under the Program

**Financial Assistance:** NCEF will offer a combination of zero-interest loans and forgivable loans to eligible homeowners to own solar and/or enabling upgrades. Financial assistance is designed such that participating homeowners experience the minimum 20% utility bill savings, inclusive of all direct and indirect costs associated with receiving the NSFA financial assistance and installing the solar project.

**Technical Assistance:** NCEF will regularly provide participating households with information about opportunities to further reduce household energy costs, including education about complementary upgrades and stacking other non-solar federal, state, and utility incentives. Examples include: NCEF's residential energy audit incentive, NCEF's Residential Energy Upgrade Program (RE-UP), USDA Home Repair (Section 504), Nevada's forthcoming home electrification and energy efficiency rebates, weatherization assistance, NV Energy incentives, and the IRS Section 25C and 25D tax credits.

NCEF provides participants with access to vetted contractors, who will be monitored for compliance with minimum contract requirements and disclosures in accordance with all applicable laws, regulations, and best practices, including performance guarantees.

## 3. Eligibility Criteria

#### **Eliqible Households:**

Households must meet the following criteria to be eligible as a program participant:

- Households must own and occupy a single-family home as their primary residence.
- Households must have sufficient tax liability to monetize the IRS Section 25D tax credit. Attestation of household's ability to use the Section 25D tax credit will be required. NCEF provides education about available tax credits, but NCEF assistance does not constitute tax advice and participants should consult a tax professional for more details.
- Household must not have received financial assistance (i.e., loans, rebates, or cash/cash equivalent) from any other <u>Nevada Solar for All</u> program at the time of application. In addition, the household is the participant, not the individual within the household that applies. A single household cannot subscribe to the program multiple times or simultaneously participate in the Nevada Solar for All Community Solar Subscription program.
- Households must not be participating in other programs that provide solar benefits, such as NV Energy's Expanded Solar Access Program.
- Households must demonstrate that their rooftop is suitable for installing rooftop solar (the <u>NSFA community solar subscription program</u> can enable single-family households to benefit from solar in Nevada even if their property is unsuitable for solar).
- Households must be located in Nevada and must meet one of the following criteria:
  - Households located in a census tract identified as low-income and disadvantaged, as included in Appendix 1; or
  - Households meeting at least one of the income qualification pathways in Table 2.

- or any other verified government or non-profit program serving Asset Limited, Income Constrained, employed (ALICE) individuals or households designated by the EPA Administrator

Applicants are required to submit address, income, and utility bill information when applying. NCEF and its partners will perform due diligence on the applicant and the project specifics (e.g., the contractor's quote) prior to executing an agreement with the single-family homeowner. Due diligence will consider whether dwelling is a suitable candidate for rooftop solar, including evaluation of the household's Energy Usage Intensity (EUI), or equivalent, based on utility bills submitted in the application. Households that do not expect to be able to monetize the Section 25D tax credit, or which have high EUI, may be better candidates for other energy efficiency programs or Nevada Solar for All programs, such as the single-family third-party ownership option or the community solar subscriber option. NCEF and/or its partners will provide these recommendations directly to applicants.

#### **Eligible Technologies:**

- Residential-serving rooftop solar: The project must be a "behind-the-meter" residential rooftop solar photovoltaic (PV) power-producing facility, be between 1 kW AC and 5 kW AC. NCEF may consider applications for projects over 5 kW on a case-by-case basis, subject to project review and the household's Energy Usage Intensity.
- **Enabling upgrades**: Where the costs of enabling upgrades are not directly incorporated into the rooftop solar system cost, NCEF's financial assistance may support enabling upgrades when there is certification from a contractor that they are necessary to deploy the solar installation and approved by NCEF, for any costs above relevant state or utility incentives. These include:
  - Roof and structural repairs;
  - Electrical panel and wiring upgrades;
  - Tree trimming or removal that improves system performance or siting; and
  - Other necessary infrastructure upgrades to be approved on an ad-hoc basis

## 4. Application

**Step One**: Prospective participants can first verify their eligibility by referring to the census tract eligibility requirements in Section 2.3 and Appendix 1, and/or to the income eligibility requirements presented in Section 2.3 and Appendix 2. <u>Households are strongly encouraged to proceed to Step Two if they have any uncertainty or confusion about their eligibility.</u> NCEF and its partners will confirm eligibility during application review.

**Step Two**: interested households should submit a response to NCEF's Solar for All Screening Form at https://form.jotform.com/NCEF/nevada-solar-for-all.

**Step Three:** the Solar for All Screening Form will redirect the applicant to the correct Solar for All program, based on the applicant's responses.

#### Other Details:

- Application timing: Households may apply for and receive financial assistance under this
  program through April 2029. Applications are accepted on a rolling basis.
- Application assistance: Applicants may also learn more through the community outreach
  programs that NCEF provides in partnership with community-based nonprofits, in

#### 5 Other Information

#### **Tax Credit Monetization**

The program is designed for households residing in single-family homes and who can directly monetize the Section 25D Investment Tax Credit (ITC) to enable them energy savings. Homeowners can claim the 25D tax credit upon filing a tax return for the fiscal year in which the property is installed. The Inflation Reduction Act set the residential clean energy property tax credit at 30% of qualified expenditures for all property placed in service before January 1<sup>st</sup>, 2033. Qualified expenditures include<sup>1</sup>:

- solar electric property (solar panels);
- labor costs associated with onsite installation; and
- labor costs associated with onsite interconnection

The qualified expenditures exclude roof repairs or modifications that are not part of the solar installation. Rebates considered to be tax-exempt adjustments to the purchase price must be deducted from the cost basis prior to calculating the credit amount. NCEF encourages homeowners to consult a tax professional with regard to their ability to monetize the tax credit and how to calculate their potential benefit. NCEF does not provide tax advice.

#### **Renewable Energy Certificates**

Solar projects generate Renewable Energy Certificates (RECs). RECs are legal and market-based instruments representing the property rights to the environmental, social, and other non-power attributes of renewable electricity generation.<sup>3</sup> The Program's funding agreements will stipulate that NCEF has claim to the RECs, with exceptions considered on a case-by-case basis.<sup>1</sup>

#### **Contractors**

Participants must work with solar contractors who belong to NCEF's vetted contractor network. NCEF evaluates contractors to ensure they are properly licensed and insured, comply with state regulation and consumer protection laws, and adhere to best practices in solar system design, operation, and maintenance. This is intended to ensure that all contractors installing systems under Nevada Solar for All possess the necessary knowledge, expertise, and experience to optimize system performance and longevity throughout the estimated 20-year project lifetime. ## Appendix 1: Eligible Census Tracts for Community Solar Project Subscribers

To confirm the eligibility of your census tract, look up your 11-digit census tract geographic identifier (GEOID) under the 2020 census tract boundaries by entering your address in the Census Bureau mapping tool available at <a href="www.census.gov/data/data-tools/2020-census-tract.html">www.census.gov/data/data-tools/2020-census-tract.html</a>. The 11-digit number is your census tract and will be in the table below if it is an eligible census tract. You may use the search function in your browser or .pdf viewer or use the "Control-F" (PC) or "Command-F" (Mac) keyboard shortcut to search the below tables for your 11-digit census tract identifier. If your census tract is not listed in these tables, you still may be eligible for participation (see Section 2.3 and Appendix 2). Interested households are strongly encouraged to apply if they are uncertain about their eligibility.
